


- . to any processing that may lead to a change of the nature of the material,
- . to any checking of reciprocal compatibility of the material with the food in contact, and, especially, the respect of the taste and the odour of the food.

Moreover, we recommend to verify the migration of the finished article, in case of contact with fatty food, because the vinyl acetate concentration is more than 10 %.
