The Plastics Directive 2002/72/EC was repealed with immediate effect on May 1, 2011. Since May 1, 2011, food contact plastics are subject to Regulation (EU) No. 10/2011 throughout the EU. With regard to the tests performed, the samples comply with the requirements of Regulation (EU) 10/2011 incl. all amendments and/or supplements published at the time of issue.

No restricted substances are used in the above-mentioned products.

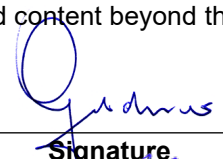
