Japanese Compliance All substances (polymers, monomers and additives) used in Vikan products comply with Article 18(3) of the Japanese Food Sanitation Act and are listed in Tables 1 and 2 of Appendix 1 of the Positive List. Migration analysis plastics Samples of the product, or a similar product made from identical plastic material, have been tested for overall migration according to the test conditions specified in (EU) 10/2011 for repeated use, and the article comply with the overall migration limit of 10 mg/dm² or 60 mg/kg. Test conditions for overall migration were OM0 (30 min at 40 °C) Food simulants used for overall migration were 50 % ethanol (simulant D1) and 3 % acetic acid (simulant B). Compliance with specific migration limits, and other restrictions, has been documented through testing, calculation or simulation. General
