### SECTION 4: FIRST AID MEASURES

#### 4.1 Description of first aid measures:

The symptoms resulting from intoxication can appear after exposure, therefore, in case of doubt, seek medical attention for direct exposure to the chemical product or persistent discomfort, showing the SDS of this product.

##### **By inhalation:**

Above all prevent the formation of any vapour-air flammable mixtures, through either ventilation or the use of an inert medium. Remove any source of ignition. #### 6.3 Methods and material for containment and cleaning up:
